During the initial consultation, a thorough eye examination will be conducted. It can be completed within one hour or one hour and thirty minutes. We will discuss the professional treatment options for your eye care needs. All inquiries and issues will be addressed during this session. It is important to note that certain medical conditions, such as pregnancy, breastfeeding, and the use of certain medications, may prevent patients from being eligible for surgery. Please remember to inform the consultant about any medical conditions you may have during the initial consultation.

The Ophthalmic surgeon is here to address any inquiries you may have. The surgeon will also discuss the risks and complications associated with the procedure.

Before the surgery, we consistently strive to ensure the patient's satisfaction by providing thorough explanations and additional beneficial information. It is important to note that while the treatment can effectively correct your vision and we have confirmed the stability of your prescription during the consultation, there is a chance of experiencing additional changes in your eyesight, such as short-sightedness, long-sightedness, or astigmatism in the future. The optometrist will give you further details during your initial consultation.

It's important to note that lens replacement surgery does not address other underlying causes of vision impairment, such as amblyopia (lazy eye), vitreous opacities (floaters), glaucoma, diabetes, age-related macular degeneration, or any other retinal or optic nerve conditions.

POTENTIAL RISKS

Every surgical procedure carries inherent risks. At Eagle Eye Care, we are dedicated to assisting our patients in achieving a fulfilling life through our top-notch eye care service. Thus, maintaining transparency is crucial to accomplish this objective.

We have highly skilled clinicians who are fully qualified to handle any rare complications that may arise. It is essential to mention that no records of any potential risks associated with Eagle Eye Care exist. Nevertheless, it is crucial to be aware of potential risks during surgery.

During Lens Replacement Surgery, whether there are additional eye problems, such as cataracts, the natural lens cannot be reinserted once it has been removed. However, a lens exchange procedure can be performed if deemed medically necessary. Here, the implanted IOL is replaced with a different lens.

- Infections after Lens Replacement Surgery are sporadic and occur only in exceptional cases. This infection is commonly referred to as endophthalmitis, which affects the inner part of the eye, and microbial keratitis, which affects the eye's outer layer. Notably, these infections are frequently observed in patients who wear contact lenses for an extended duration.
- Rare instances of permanent reduction in best correctable vision and cardiac or respiratory problems have been reported.
- Patients may also experience rare complications such as swelling around the eye, corneal abrasions, inflammation within the eye, bleeding inside

the eye, damage to the lens support capsule or membrane, opacification of the intraocular lens, displacement or dislocation of the lens implant, remnants of the natural lens causing inflammation, retinal complications including central swelling, retinal detachment, vitreous opacities or floaters, wound leaks, elevated intraocular pressure (IOP) leading to glaucoma, and droopy eyelids or double vision. These are potential complications that may occur. Please note that the incidence of these complications occurring after lens replacement surgery with Eagle Eye Care is very rare.
